#### **What personal data we hold on you**

#### **Why we need your personal data**

The reasons we need to process your data include:

3. To share resource material to promote Mental Health Awareness/Events
4. To offer support and educational information to our members

#### **Who we share your personal data with**

When you sign up as a member of S.P.O.R.T.S., any information held, we will not supply any personal data it holds for this purpose to any other third party.

### How long we hold your personal data

We will hold your personal data for as long as you are a member with S.P.O.R.T.S. Membership data is updated annually on or before 31st October. Any personal data we hold on you will be securely destroyed after four years after you have ceased to be a member of S.P.O.R.T.S. Your data is not processed for any further purposes other than those detailed in this policy.

### Your rights regarding your personal data

As a data subject, you may have the right at any time to:

- Request access to, rectify or erase your personal data.
- Restrict or object to certain kinds of processing of your personal data, including direct marketing, and
- Complain to the UK's data protection supervisory authority, the Information Commissioners Office, about the processing of your personal data.

As a data subject, you are not obliged to share your personal data with S.P.O.R.T.S. However, if you choose not to share your personal data with us, we will not be able to process your registration to continue to be a member of S.P.O.R.T.S. in absence of the necessary data to fulfil registration requirements.
